## MINUTES Regular Meeting Okabena-Ocheda Watershed District Board of Managers March 7, 2023

The regular meeting of the Okabena-Ocheda Watershed District Board of Managers was called to order at 4:00 p.m. Present were managers Steve Bousema, Rolf Mahlberg, Jay Milbrandt and Jeff Rogers. Also present were: Kari Lucin, Globe reporter; Bob Demuth, County Commissioner; Al Langseth, district resident; and Dan Livdahl, administrator.

The regular board meeting for February was cancelled due to a lack of a quorum. Rogers moved to approve the January 31, 2023 special board meeting minutes. Milbrandt seconded the motion. Affirmative: Bousema, Mahlberg, Milbrandt, Rogers. Opposed: none. Motion carried.

The Treasurer's report and bills payable were discussed. The first half of the state Crailsheim project grant was deposited electronically in the First State Bank SW checking account. One or more separate accounts will be opened to keep the grant money separate from other district funds. Bousema moved to approve the Treasurer's report and pay the bills. Milbrandt seconded the motion. Affirmative: Bousema, Mahlberg, Milbrandt, Rogers. Opposed: none. Motion carried.

## **OLD BUSINESS**

The Crailsheim water quality pond engineering scope of services proposal from Houston Engineering was discussed. Rogers moved to sign the services agreement as reviewed. Milbrandt seconded the motion. Affirmative: Bousema, Mahlberg, Milbrandt, Rogers. Opposed: none. Motion carried.

The managers discussed opening accounts at First State Bank SW for the Crailsheim project grant money. Milbrandt moved to open a money market account with a balance of approximately \$90,000, invest \$90,000 in a 7- month CD, and \$305,000 in a 13-month CD, with Mahlberg, Milbrandt and Livdahl as authorized signatures on the account and CDs. Rogers seconded the motion. Affirmative: Bousema, Mahlberg, Milbrandt, Rogers. Opposed: none. Motion carried.

The managers discussed purchasing CDs with funds in the money market account at Worthington Federal Savings Bank. Rogers moved to invest \$100,000 in a 12-month CD and \$90,000 in a 9-month CD at Worthington Federal with Milbrandt, Mahlberg and Livdahl as authorized signatures. The signature card for the money market account will also be updated to include Milbrandt, Mahlberg and Livdahl. Milbrandt seconded the motion. Affirmative: Bousema, Mahlberg, Milbrandt, Rogers. Opposed: none. Motion carried.

The school board approved the permanent and temporary construction site easement boundaries for the Crailsheim pond project. Houston engineering will survey the boundaries and create legal descriptions after snowmelt. An attorney will be contacted to produce the easement document when the legal description is complete.

## **OLD BUSINESS**

Drafts of the 2022 annual report and 2023 annual plan were distributed to the managers at the January 31<sup>st</sup> special meeting and by email last week. Milbrandt moved to approve the 2023 annual plan. Rogers seconded the motion. Affirmative: Bousema, Mahlberg, Milbrandt, Rogers. Opposed: none. Motion carried. Rogers moved to approve the 2022 annual report. Milbrandt seconded the motion. Affirmative: Bousema, Mahlberg, Milbrandt, Rogers. Opposed: none. Motion carried. Rogers. Opposed: none.
